Using the TEAM Approach and Digital Planning to Achieve Predictable Results with Single and Multi-Unit Implant Rehabilitations

Implant dentistry has significantly evolved over the last four decades. Now more than ever, patients are educating themselves, via online sites, regarding the benefits that endosseous dental implants may provide. Many of these patients are referring themselves to dentists that advertise online solely based on what they read on a website. One business system that appeals to prospective patients is the “one office” experience model where all treatment occurs in one location by one or more clinicians. Although advanced technologies available today allow us to diagnose, treatment plan and perform patient treatments with dental implants at very high success rates and lower morbidity rates, patients expect that their dental care be performed with the fewest possible number of surgeries and procedures, in shorter time frames, with the best possible aesthetic and functional outcomes.

Suffice it to say, the average patient today wants a predictable result, in a simplified, convenient and streamlined process. Aesthetic procedures, immediate loading, immediate provisionalization, specialty implants, digital case planning and guided surgery will be discussed in detail. Business skills including patient communication, intra-office communication, inter-office communication will also be covered. These two sessions will cover the modern day TEAM approach to dental implant therapy.
