Patients often present needing 'just one tooth fixed,' but when you look in their mouth a collapsed vertical dimension leaves no space for a restoration. One tooth becomes a whole mouth and instantly the entire case escalates. How do we recognize the signs of a worn dentition? What if the teeth can't be utilized in the final restoration? This course will review how to properly analyze the worn dentition, and execute a full mouth rehabilitation. We will discuss:

- How to analyze conditions in the mouth and forecast the outcome
