Restorative Implant Complications & How to Manage Them

Teeth and dental implants differ in many ways. Occlusion, cementation, screw retained processes, and case maintenance, are a few differences that clinicians need to understand. If procedural changes are not evaluated, you may encounter a complication, and the way you manage them, can make the difference between a successful outcome, or one that is less than satisfactory. Strategies must be in place and clinicians should be able manage these differences before and after treatment should they occur.
