These three sessions will include both lecture and treatment planning with a focus on how to predictably transition a patient from natural teeth to dental implants. Biologic and prosthetic principles that are critical to achieve enhanced aesthetic and functional results will be reviewed. We will take advantage of numerous clinical cases to reinforce the group's understanding and application of these principles.

Each session will involve a restoratively focused lecture, followed by discussion using active clinical cases. We ask that all doctors work to identify at least one case for Dr. Castellon and the ColumbusOMS surgical team to review with the group. **Dr. Border will help compile all clinical cases. Aesthetic dentistry is a rapidly changing discipline. As more anterior teeth are being replaced with dental implants, factors such as tissue management, loading and materials need to be considered. Proper diagnosis and treatment planning is essential for success.

Fundamental Restorative Considerations: Single Unit Implant vs Traditional FPD

Implant-supported restorations present various advantages and disadvantages based upon the method of retention employed. This restorative decision making process can prove challenging for clinicians. The ease of fabrication and cost, esthetics, screw access, occlusion, retention, retrievability, restriction of implant position, effect on peri-implant tissue health, provisionalization, immediate loading, and clinical performance are a number of the crucial deciding factors.

SESSION #3

A Systematic Approach in Treatment Planning the Edentulous Patient

Many options are available to the clinician to provide full arch dental implant therapy to patients with a failing dentition. Some patients are candidates for full arch, immediate, provisional restorations while others are more appropriately treated with a staged approach.

Course objectives:

- Recognize the diagnostic needs for anterior dental implant therapy.
- Understand the biologic principals of implant mapping and decision making
- Understand which provisional restorations are most appropriate for a given restorative plan.
- Describe the biologic principles that drive optimal results in the esthetic zone
- Employ soft tissue management with the use of a temporary prosthesis.

Course objectives:

- To recognize and understand occlusion as it relates to the dental implants.
- To learn how to prevent complications related to faulty occlusion, or faulty prosthetic design.
- To learn how to choose between screw or cement retention based on implant position.
- To recognize and understand periimplantitis, and other related implant complications.
- To recognize and understand retention form, implant inclination and abutment design.

Course objectives:

- Diagnose and treatment plan a patient with a failing dentition and determine the best course of treatment.
- Understand techniques and materials used for the fabrication of provisional prosthesis
- Decide which restorative materials should be used in the final restorations
- How to maintain final restorations
- To select the ideal treatment based on this classification
