

# Oral Cancer and their Mimics: An Update

This course focuses on oral cancer presentation, discusses differential diagnosis, and provides a broad overview of diagnostic procedures by which definitive diagnosis can be reached. This course will also present common nodular and salivary lesions as well as pigmented lesions of the oral mucosa.

## Radiographic Lesions in the General Dental Practice

Radiographic benign, locally aggressive, and malignant lesions presenting as unilocular/multilocular radiolucent lesions or mixed radiolucent-opaque lesions are numerous. Radiographic pathology is encountered in general dental practice. An overview of the most common radiographic lesions will be presented including their differential diagnosis.
